Project Description/Justification:

Detailed Project Justification:

Current sites for consideration are Angoon and White Mountain. Storage Facility sites are Manokotak, Napaskiak, and Toksook Bay. The National Guard Bureau provides for the construction of 2-3 new Federal Scout Armories in Alaska per year. While the federal funding is available and the need exists, we will continue with the program and request Federal Authority from the state. Three additional storage facilities have been included in the request in lieu of a third Federal Scout Readiness Center.

The new facilities provide a higher state of readiness to respond to local and national emergencies and mission requirements. Operating costs are reduced as the new readiness centers are more energy efficient and require less maintenance. Economically, these projects provide economic activity when materials are purchased and construction labor is utilized in the local areas. Locations are subject to change due to various factors such as troop strength, land availability and environmental assessments.

It is imperative to receive the federal authority while the program continues from the National Guard Bureau to provide updated facilities in the State of Alaska for the Army Guard.
