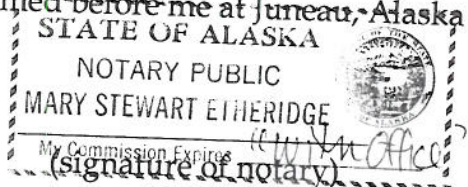
- 26) I do not believe that I spoke with Kris Perry in regards to Mike Wooten.
